Sheriff Eslinger,

On October 8, 2010, your office received U.S. Certified mail # 7009 0820 0001 5217 4068, accepted by B. HAGGARD.

The letter concerned a request for the investigation of Sgt. Michael Laney and allegations he made regarding violations of Seminole County Sheriff's Office General Orders as well as State and Federal laws. As of this date your office has failed to reply to my request and appears to be taking no action concerning the allegations made by Sgt. Laney. Your office has failed to contact me in order that I could provide your office with the documented evidence in support of the aforementioned allegations of criminal actions.

It is my belief that your office does not intend to investigate this matter due to your direct first hand knowledge and involvement in the incidents described by Sgt. Laney. As a Citizen, business owner and tax payer of Seminole County, I have utilized the proper and legal channels afforded by law in order to have this issue addressed by the Office of the Sheriff of Seminole County.



You can take comfort in the fact that I intend to keep looking into your actions as well as the actions of other men and women of the same character, integrity and honesty that you display. And let them choose if they want to be associated with persons of this nature or have their photograph taken with them.
